Dr. Lynn Witherspoon is a graduate of the University of Wisconsin Medical School in Madison. He trained in Internal Medicine and Nuclear Medicine at the Ochsner Medical Institutions in New Orleans and Duke University Medical Center in Durham and is Board Certified in both. After serving in the United States Navy, he joined the staff of the Ochsner Clinic in New Orleans where his practice included Endocrinology, Nuclear Medicine, and the creation and management of Ochsner's immunoassay laboratory.



Dr. Witherspoon served in an Informatics role or as CIO during much of his Ochsner career. He conceptualized and built a clinical repository in the mid-1980's and subsequently shepherded the design, development, deployment, and certification of Ochsner's legacy EHR platform. Since 2009 Ochsner has implemented a broad suite of practice support, billing, medical record, and clinical applications from Epic. Dr. Witherspoon is now System Vice President and Chief Medical Information Officer for the Ochsner Health System.

In his 12 years at RelayHealth, he's held leadership positions in engineering, product management and business development focused on interoperability. He led the architectural development of RelayHealth's Health Information Exchange platform focusing on electronic health record (EHR) connectivity, patient identity, clinical terminology, and patient consent. Chris currently leads a team responsible for representing McKesson's HIE and Analytics technologies in business development to assess alignment with customer strategic objectives.



Prior to joining RelayHealth, Chris was an engineering director for six years at Commerce One, a pioneer in the Internet business-to-business market. Commerce One developed procurement and supply chain management solutions and created many early XML and web services technologies. He is an early innovator in the field of XML-based interoperability and is lead inventor of two XML patents in transformation and version management. He started his career at Gnosso Software, a Washington DC based software company that developed Political Action Committee and Lobbying information solutions. He held lead positions in product development and professional services. Chris earned his bachelor's in Computer Science from Dartmouth College in Hanover, New Hampshire. He lives in Berkeley, California with his wife and two children.

Allison has been named a "20 In Their 20s" by Crain's Chicago Business and her work has been published in the *Journal of Medical Ethics*. She has spoken across the nation on various health care technology topics and has served as an innovation workshop lead at Singularity University's Exponential Medicine Conference. Allison also serves as a mentor to biotech start-ups in MATTER, a Chicago-based accelerator aiming to grow next-generation diagnostics, biopharma, health IT and medical device businesses. Allison is also the cofounder and chief informatics officer of Resonance Medical, LLC, a neuroinformatics company that is developing novel brain-machine interfaces and drug delivery technologies. Allison earned her master's degree in bioethics and health policy from Loyola University Chicago and her bachelor of arts degree in biology from Illinois Wesleyan University. Allison and her husband, Chris, live in Evanston, IL, with their two chinchillas, Lucy and Oliver.

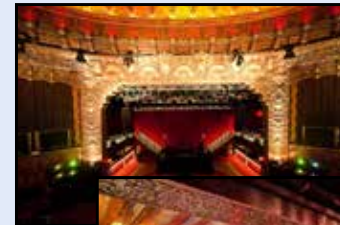
DINNER & ENTERTAINMENT
